### **K-12 Digital Curriculum**

Prentiss County School District (hereafter referred to as PCSD) is soliciting vendors to participate in a reverse auction for electronic and digital curriculum materials for math and ELA for grades K-12. PCSD has an expressed commitment to quality, accuracy & accessibility in the selection of digital materials, including alignment to Mississippi College and Career Readiness Standards. All submissions must include a comprehensive strategy for providing professional development for district teachers and staff.

Central to the needs of the District are products that entail the following:

- Digital Resources:

- may include a fully web-based version of the complete curriculum, including interactive, and multimedia features appropriate for student use, and including home use
- may include supplemental digital materials and enhancements such as virtual manipulatives, interactive games, and video appropriate for collaborative and individual learning environments
- may include online professional development components and additional instructional planning resources for teachers
- all electronic resources, digital components, features, demonstrations, virtual labs, and content must be fully accessible and operational on Apple iOS, MacOS and Windows 10 platforms at minimum
- Flash-only video resources must also be available in HTML5 or comparable language for iOS delivery. All digital content must be exportable as PDF or locally stored library on a student device, even if temporarily, for students needing to access material while offline. (other offline accessibility features and options will be considered and evaluated)
- Students Information System Synchronization:
  - All digital and non-digital resources requiring rostering or the loading of class lists, teacher lists, and/or course schedules must be compatible with data housed in SAMS (Central Access) and Canvas learning management system (Instructure). Preference will be given to vendors with the ability to sync through a vendor-provided roster import tool. Manual-only rostering options will not be considered as viable and sustainable curriculum resources. The use of vendor-provided import tools must be included as part of the base price for purchase and not offered as additional, for-purchase add on features.
- Differentiated Instruction
  - Must include intervention and enrichment opportunities as well as materials to support differentiation. Clear outline of various learning formats and opportunities for hands-on strategies and engaging activities. Students are provided opportunities to respond through various modalities: visual, auditory, and kinesthetic. Instructional materials and supplemental resources should adhere to the principles of universal design for learning (UDL).
- Prices
  - The Bidder shall prepare a proposal that describes their best commodities that the offeror desires to make available and the appropriate pricing structure.
  - All prices must be quoted less any Federal Excise or Sales Taxes from which PCSD is exempt.
  - All proposals must include shipping charges. Shipments will be made to each school individually.
  - Proposals must be signed by an individual authorized to bind the vendor to a contract.

- Prices must be guaranteed firm offers from the date of reverse auction through allowing sufficient time to evaluate proposed electronic textbooks and digital resources for instructional purposes.
- All proposals must be for the latest, most current edition or publication date
- Please list pricing per year as well as any price break points on contract. (For example, if purchasing 3 years on one contract costs less than single year renewal fees please include that information in the submission.)

### **Procedure for bidding.**

The reverse auction will be conducted in a Zoom Meeting by invite only. You must fill out the Prequalification forms to be invited.

The bidder must use the chat function to submit bids.

The bid will consist of 4 rounds – Technology and Technology Accessories, K-12 Digital Curriculum, Commodities, Buses

Each round will consist of 30 second segments organized by each line item.

Bid difference must exceed \$1 from previous bid.

At the beginning of each segment, a 30 second timer will start, and each bidder will be allowed to enter one bid for that line item in the chat.

Prentiss County School District will take the bids and prequalification information into consideration and contact the bidder that will be awarded.

The auction will be recorded.
